WHO CAN PARTICIPATE IN THE REBATE

Any Chevron direct (invoiced by Chevron) customer who purchases the minimum required **new volume*** of any of the qualifying products on a single invoice between February 1, 2023 and September 30, 2023 can claim a rebate of up to \$500.00 USD/\$673.00 CAD. (Minimum single invoice volume = 110 gallons/416 litres).

110 gallons/416 litres of any qualifying products on a single invoice between February 1, 2023 and September 30, 2023 can claim a rebate of up to \$500.00 USD/\$673.00 CAD.

*New volume is defined as product that has not been purchased in the past 6 months.

HOW THE PROMOTION WORKS

Chevron will pay a rebate (by check) of up to \$1.00/ gallon USD or \$0.34/litre CAD for every gallon/litre of Qualifying Products purchased during the Promotion Period. Promotion Period maximum total claim amount per customer: \$500.00 USD/\$673.00 CAD.

Note: Bulk and packaged goods ordered on the same order, but invoiced under separate cover, will qualify.

Multiple claims per qualifying customer can be filed during the Promotion Period by the customer up to the maximum \$500.00 USD/\$673.00 CAD rebate allowed during the Promotion Period. Minimum qualifying gallons per single invoice: 110 gallons/416 litres. Invoices must be submitted by October 15, 2023. Invoices received past claim deadline will not be accepted.

FILING A CLAIM

During the Promotion Period, the customer uploads a copy of qualifying invoice(s) to the rebate claim site: **direct.chevronpromos.com**. Claim must include volume of qualifying product(s) and required information including mailing address for the rebate check. Customer rebate amount is calculated on the site.

Customer CAN file multiple claims during the Promotion Period to maximize total rebate (up to \$500.00 USD/\$673.00 CAD).

Claims will be processed, and rebate check(s) will be mailed directly to the customer based on the mailing address provided in the claim. All checks are made payable to the customer named in the claim and documented on the invoice. Checks will be mailed throughout the Promotion Period for qualifying/valid claims. Please allow 4 weeks after a valid claim has been submitted for receipt of rebate check. Chevron reserves the right to audit any claim.

Minimum qualifying gallons per single invoice: 110 gallons/416 litres. Maximum total claim for single claimant for the duration of the Promotion Period is \$500.00 USD/\$673.00 CAD (based on claimant physical address as indicated on uploaded invoice). Claims for less than 110 qualifying gallons/416 litres on a single invoice will not be processed. Claims with duplicated invoices will not be processed.
